1. Executive Summary

RockToken (the issuer) issues RockCoin (ROCK), a utility token on BNB Smart Chain (BEP-20). RockCoin powers RockToken's cloud-mining ecosystem, staking roadmap, community incentives, and planned governance features.

Key facts: Phase 1 completed and secondary market listing on Jul 6, 2023. Phase 2 Public Sale scheduled Sep 1 – Dec 25, 2025. Total supply is fixed in the token smart contract; subsequent releases are staged and pre-disclosed.

2. Company Overview

RockToken is focused on making mining and token utilities accessible without requiring users to operate hardware. The company combines established infrastructure, transparent on-chain operations, and a user-centric product roadmap.

Mission:

Empower users globally to access crypto mining and token utilities through a secure, simple, and scalable platform.

Vision:

Build a trusted mining-centric crypto ecosystem where RockCoin aligns incentives between users, partners, and developers.

3. Market Opportunity

Cloud mining and utility tokens occupy a niche that reduces technical barriers while incentivizing participation. Growth drivers include increased demand for staking, accessible rewards, and simplified custody for retail participants.

Target markets include retail crypto users, emerging markets with limited hardware access, and partners seeking staking/reward integrations.

4. Product & Services

Cloud Mining

- Hardware-free mining subscriptions with visible performance metrics and daily reward distribution.
- Dashboard, referral programs, and mobile access.

Planned Features & Utilities



- Staking module (subject to regulation and phased rollout).

7.3 Vesting & Release Principles

- Team & Advisors: Suggested 12–24 month vesting with a 3–6 month cliff.
- Public Sale: Transparent schedule with a limited TGE and linear unlock thereafter.
- Reserve & Bonus: Programmatic releases tied to ecosystem milestones.
- Community Incentives: Periodic allocations aligned with measurable outcomes.

7.4 Sale Parameters (Summary)

- Phase 1: Completed; listed for secondary trading on Jul 6, 2023.
- Phase 2 Public Sale: Sep 1 – Dec 25, 2025.
- Accepted currencies, sale price, caps, and whitelisting will be announced prior to sale.
- Total supply fixed; no additional minting will occur beyond contract-defined supply.

8. Roadmap (Past & Future)

Eight Key Milestones

Q1 2023 — Project Kickoff & Market Research: Team formation, tokenomics draft, technical scoping.

Q2 2023 — Partnerships & Core Development: Strategic alliances and core platform build.

May 2023 — Whitepaper Release & Security Audit: Documentation, audits and remediation.

Jun 2023 — Phase 1 Pre-Sale Launch: Early-stage sale to community and supporters.

Jul 6, 2023 — Phase 1 Completed & Secondary Market Listing: Trading available on secondary markets.

Sep 1 – Dec 25, 2025 — Phase 2 Public Sale: Broader public sale with transparent vesting schedule.

Early 2026 — Phase 2 Listing & Mainnet Launch: Post-sale listing and platform go-live.



Q2 2026 — Ecosystem Expansion & Global Marketing: Iterations, partnerships, and scale-up.

9. Technology & Security

Standards & Architecture

- BEP-20 token contract on BNB Smart Chain.
- Audit-ready code base with external security reviews.
- Role-based treasury controls and multi-sig where applicable.

Security Practices

- Routine monitoring and incident response playbooks.
- Responsible disclosure and bug bounty program (planned).
- Encrypted storage of sensitive credentials and operational secrets.

10. Governance & Community

Community-driven governance is planned in phases. Initial governance will be advisory and community-informed. Over time, selected parameters (grant allocation, feature prioritization) may be subject to token-holder voting.

- Transparency reports on token releases and treasury movements.
- Community channels for proposals and feedback.

11. Go-To-Market & Partnerships

Marketing will prioritize education, transparency, and sustainable user acquisition. Strategic partners include wallet providers, exchanges, and infrastructure vendors.

- Progressive geographic rollout aligned with compliance.
